On February 17, 1989, a confidential source (hereafter referred to as SOURCE), advised that CARY HARTMAN, is presently incarcerated at Cedar City, Utah, on the charge of rape. On Sunday, February 12, 1989, HARTMAN viewed a television show entitled B. L. STRYKER. The show that night depicted a sexual assault and murder. After viewing the show, HARTMAN acted in a different manner.

SOURCE learned that HARTMAN made references to a kidnap victim by the name of SHEREE WARREN. HARTMAN spoke about the circumstances surrounding her disappearance in the third person. Over the next few days, HARTMAN stated four times that he was the last one to see her alive. He said that she was slipped a pill which incapacitated her. She was then sexually assaulted and strangled, and her body buried by a huge grey boulder surrounded by trees, to include a pine tree. Her body would be found in Cottonwood Canyon, 23½ miles from where she was last seen alive.

SOURCE has learned that HARTMAN claimed to have made two cassette tapes narrating the circumstances regarding the disappearance of WARREN. These tapes were given to the attorney who defended HARTMAN during his trial on the rape charge.

SOURCE learned that on one occasion, HARTMAN was looking at a newspaper article depicting TED BUNDY along with photos of many of his victims. HARTMAN placed a "X" by the photos of five of BUNDY's alleged victims.

On February 21, 1989, a confidential source (hereafter referred to as SOURCE), learned that CARY HARTMAN had placed "something" in a drink which he then gave to SHEREE WARREN. After WARREN was incapacitated, HARTMAN left his residence and went to a bar to establish an alibi. At the bar he had a beer and made a couple of telephone calls, one to the local police department, and one to WARREN's mother. Both of these telephone calls were made inquiring as to the whereabouts of WARREN. The local police department advised HARTMAN that he had to wait 24 hours before filing a Missing Persons Report. After leaving the bar HARTMAN then returned to his residence where he placed WARREN in her vehicle. He deposed of her body then drove her car to Las Vegas and flew home under an assumed name. learned that HARTMAN then stated that her body could be found 23½ miles from where WARREN was last seen alive, in Cottonwood Canyon.

SOURCE has developed information that WARREN called HARTMAN at home the day of her disappearance; she was to meet him at his residence. HARTMAN was drinking on the night of WARREN's disappearance. On that same night, the two of them had an argument. The argument was in regard to HARTMAN stating that he was going out drinking with one of his buddies. As a result of the argument, WARREN was in an incapacitated state. That same evening, HARTMAN contacted WARREN's mother and the police department inquiring as to WARREN's whereabouts.

SOURCE has learned that HARTMAN has been arrested twice in the past for making obscene telephone calls. SOURCE learned that HARTMAN has claimed to have nude and obscene photographs of some of the wives of the local sheriff's learned that some of these photos allegedly depict bondage scenes.

On February 22, 1989, a confidential source (hereafter referred to as SOURCE), learned that CARY HARTMAN was an acquaintance of NANCY BAIRD. BAIRD's disappearance allegedly occurred while HARTMAN was experiencing a divorce. HARTMAN refers to BUNDY as "THEODORE" and questioned why "THEODORE" was accused of involvement in BAIRD's disappearance.

SOURCE has learned that HARTMAN is suspected or known to have committed four rapes. HARTMAN has indicated that he was involved in six unknown rapes which have occurred since 1974. Allegedly, each of these rapes were preceded by telephone calls to the victim.

SOURCE has learned that HARTMAN, in conjunction with HARTMAN's father, is attempting to have another person by the name of NIELSEN (phonetic) take the blame for HARTMAN's rapes. HARTMAN was heard to say, "He would take the blame for crimes I did."
